### Dispose of your unwanted pesticides for FREE

#### Severn Trent Water's (STW) Pesticide Amnesty is open until 15<sup>th</sup> March

For farmers in the Wye Catchment to safely dispose of unwanted chemicals, pesticides and biocides, free of charge

- Check your pesticide store for unwanted/expired chemicals
- Check if any of your land is within the eligible catchment (Contact Lucinda on **07824 904 877** or email [lucinda@wyeuskfoundation.org](mailto:lucinda@wyeuskfoundation.org))
- Contact **ChemClear** before 15<sup>th</sup> March, to arrange for chemicals to be collected. Tel: **07436 077 304** Email: [chemclearltdamnesty@gmail.com](mailto:chemclearltdamnesty@gmail.com)

**You will need to tell Chemclear:-**

- Catchment name (Wye catchment in Herefordshire) & code (MD18)
  - Product name, Active ingredient, Concentration, Weight/Volume in containers.
  - Collection address and contact details (2 phone numbers & email address)
- They will assess your request & contact you after 15<sup>th</sup> March to arrange collection.*

**Maximum pesticide collection limit is 75 litres per farm**

### **Countryside Productivity Small Grant (CPSG) Scheme.**

- The initial offer is for £15 million of **small grants of between £3,000 and £12,000 for a range of equipment and technology to be used on farms**
- Applications will be scored after the closing date and applicants should be notified soon afterwards as to whether they have been successful.

- The page includes links to the **Handbook** and a portal to a **very simple online application form**.
- Applying online takes just a few minutes.
- Grants are available for a **specified** range of equipment.
- **Applications for this round of funding are due in by 14<sup>th</sup> March 2018.**

The intention is that there will be further rounds of grants later in the year.

### **Temporary Land Association (TLA) links between land in England and Wales**

Animal Health & Trading Standards (Herefordshire Council) have had a number of enquiries regarding temporary land association (TLA) linking English holdings to land in Wales.

When TLA's were first introduced the Livestock keeper was only able to link land in England to an English holding, however, this changed in 2017 and land in Wales can also be linked to an English holding.

### **Keeping your birds safe**

Following confirmed cases of Avian Influenza in wild birds in three separate locations, an avian influenza prevention zone has been declared across the whole of England. It is a legal requirement for **ALL bird keepers** to:

- Feed poultry in enclosed areas to discourage wild birds.
- Regularly clean and disinfect hard areas the birds can access.
- Minimise the number of visitors in contact with birds.
- Cleanse and disinfect footwear, equipment and vehicles which have access to bird areas.
- Ensure food, bedding and water supplies are secure from contamination.
- Implement effective vermin control.

#### **Employee must be:**

- At least school leaving age to get the **National Minimum Wage**
- Aged 25 or over to get the **National Living Wage** - the minimum wage will still apply for workers aged 24 and under

#### **Apprentices are entitled to the Apprentice rate if they're either:**

- aged under 19
- **or** aged 19 or over and in the first year of their apprenticeship

#### **Apprentices are entitled to the minimum wage for their age if they both:**

- aged 19 or over
- **and** have completed the first year of their apprenticeship

### **New rules for farmers in England to help protect water quality – from April 2018**

From 2<sup>nd</sup> April 2018 new rules for all farmers in England will be introduced to help protect water quality, by standardising the good farm practices that many are already performing and offering a new approach to regulation.

#### **In essence the rules require farmers to:**

- keep soil on the land;
- match nutrients to crop, and soil needs, and
- keep livestock fertilisers and manures out of the water.

Four new Countryside Stewardship offers have been introduced for farmers and land managers to boost biodiversity and help protect and enhance farmland and the countryside. Significant improvements have been made to the scheme to make it simpler and easier for farmers & land managers to apply.

The four new offers are **Online Arable Offer**, **Lowland Grazing Offer**, **Upland Offer** and **Mixed Farming Offer**.

All four offers are open for application, and to request an application pack call **0208 026 1089**.

**The deadline for submitting your application for each of the four offers is 31<sup>st</sup> July.**

**Countryside Productivity Scheme**

The RDPE Countryside Productivity Scheme provides funding for projects in England which improve productivity in the farming and forestry sectors and help create jobs and growth in the rural economy. It is administered by the Rural Payments Agency. Under the RDPE Countryside Productivity Scheme, there are grants for:

- **Improving forestry productivity (application deadline 3<sup>rd</sup> April 2018)**
- **Water resource management and reservoirs (application deadline 29<sup>th</sup> June 2018)**
- **Adding value to Agri-food products (application deadline 29<sup>th</sup> June 2018)**  
Grants to fund projects that improve the processing of primary agricultural products (i.e. Annex I products), benefiting the Agri-food supply chain which will in turn improve farm productivity.
- **Improving Farm Productivity (application deadline 3<sup>rd</sup> December 2018)**  
Grants to fund projects that improve farm productivity through the use of robotic equipment and systems to aid crop and livestock production; increasing the use of renewable energy produced on farm; the use of LED wavelength controlled lighting to aid crop production; more efficient use of livestock slurries and manures, and digestate.

**The RDPE Growth Programme administered by DEFRA**

**Food producers and processors and horticulture businesses are being urged to submit applications for EU funding to help their organisations grow before the 2018 deadline.** Companies operating in the food sector including businesses involved in meat processing, yoghurt and cheese production, egg packing, food and drink processing and storage facilities, and dairy, fruit or grain production can apply for grants to support their growth plans.

**Funding could pay for** constructing or improving buildings or buying new equipment and machinery. It will be awarded to projects that increase productivity, adopt new techniques, processes or innovations, and those that create business efficiencies, new jobs or new joint ventures and partnership working within a supply chain.

**Grants can cover** up to 40 per cent of eligible project costs with a minimum grant of £35,000 and a maximum grant of £170,000.

**Expressions of Interest for funding bids must be submitted by 31<sup>st</sup> May 2018.**

*The grants are made by the European Agricultural Fund for Rural Development (EAFRD), which is part of the European Structural Investment Funds (ESIF).*

**What will the LEADER Programme do?** The main objective is to create jobs and economic growth by supporting rural businesses. Programme themes are:

- Support for micro and small enterprises, including farm diversification
- Support for rural tourism
- Support for increasing farm productivity
- Support for increasing forestry provision
- Provision of rural services
- Support for cultural and heritage activities

Project applications will be eligible from:

- Micro businesses (0-9 employees) and small businesses (10-49 employees)
- Qualifying micro and small farming and forestry businesses
- Social enterprises
- Voluntary organisations
- Community groups
- Parish councils based in rural Herefordshire

**Please Note:-** The Herefordshire LEADER scheme is introducing closed rounds for the remainder of the programme. **The current round will close to new Expressions of Interest on 15th March 2018, and will re-open in early summer**, date to be published on the LEADER webpage nearer the time. This will help to manage the number of applications submitted and prioritise funding in future rounds.

### How will I know if our project is eligible?

LEADER funding contributes to around 40% of total project costs. Cash match funding will be needed for around 60% of each project. This is a predominantly capital grant programme. Training, skills and running costs are not eligible for funding. Business addresses must be registered in the Herefordshire LEADER area.

### What outputs could my project achieve?

An output is a measurable assessment of performance and success.

The main outputs for the program are: a) Jobs created & b) Businesses or holdings benefitting

**How much can we apply for?** Projects may be eligible for a grant of £2,500 up to a maximum of normally £35,000 to fund specific activities. Higher grants may be awarded to projects demonstrating exceptional output levels.

## The Jack Hughes Fund - administered by Herefordshire Community Foundation

The Jack Hughes Fund will fund up to a maximum of 70% of the cost of training or costs up to a maximum of £150.

Funding will be limited to one family member/employee per annum

### The programme will be available for farmers aged over 40

and will specifically provide funds to support those who require:

- retraining or upskilling as they are leaving the industry
- training to support a new farm diversification enterprise
- training or business support for succession planning

### Funding will also be available for the following courses:

- Safe use of pesticides – PA1, PA2, PA6
- Rodent control on farms
- Emergency first aid
- Food safety (Basic Food Hygiene)
- Chainsaw Maintenance & Cross Cutting (CS30)

**The funding is easy to access, but please note that the project will not support training retrospectively and places will be limited. Applicants need to be resident in Herefordshire.**

## The Prince's Countryside Fund

The Herefordshire Federation of Young Farmers' Clubs (HFYFC) working in partnership with Herefordshire Rural Hub have secured funding to provide support for training in a **rurally based career** to the end of December 2019. The funding is easy to access. All you need to do is select which course you would like to go on and complete the application form. If your application is approved you will be able to reclaim **70%** of your training and test costs, up to a maximum of **£250**. **Applicants must be a current member of HFYFC or a past HFYFC member (up to 40 yrs old).**

The fund will support training that will; **improve your employability, increase or improve your skill set, improve your safety or allow you to undertake extra responsibility in your current job.**

The appraisal panel meets on the first Monday of the month. Please ensure that you submit your application in good time before your course is due to take place, as training cannot be funded retrospectively.

### News from the Blues – West Mercia Police

#### Make the right call – help and advice

West Mercia Police have launched a series of help and advice pages and downloadable leaflets in the "Contact us" section on their websites. These are to support members of the public to 'making the right call' in the event of you wishing to contact us about a specific issue. There is advice on what to do in the first instance/who else you could contact/where to get further information. This in turn will reduce the number of calls going in to the West Mercia Police Communications Centre, meaning that the staff are available for emergency calls and to reduce the waiting time for anyone calling in on 101.
