#### **Keeping your birds safe**

Following confirmed cases of Avian Influenza in wild birds in three separate locations, an avian influenza prevention zone has been declared across the whole of England. It is a legal requirement for **ALL bird keepers** to:

- Feed poultry in enclosed areas to discourage wild birds.
- Regularly clean and disinfect hard areas the birds can access.
- Minimise the number of visitors in contact with birds.
- Cleanse and disinfect footwear, equipment and vehicles which have access to bird areas.
- Ensure food, bedding and water supplies are secure from contamination.
- Implement effective vermin control.

#### New rules for farmers in England to help protect water quality – from April 2018

From 2<sup>nd</sup> April 2018 new rules for all farmers in England will be introduced to help protect water quality, by standardising the good farm practices that many are already performing and offering a new approach to regulation.

#### In essence the rules require farmers to:

- keep soil on the land;
- match nutrients to crop, and soil needs, and
- keep livestock fertilisers and manures out of the water.

Four new Countryside Stewardship offers have been introduced for farmers and land managers to boost biodiversity and help protect and enhance farmland and the countryside. Significant improvements have been made to the scheme to make it simpler and easier for farmers & land managers to apply.

The four new offers are **Online Arable Offer, Lowland Grazing Offer, Upland Offer** and **Mixed Farming Offer**.

The **Online Arable Offer** opens for application on **20**<sup>th</sup> **February**.

The other 3 offers are open for application, and to request an application pack call 0208 026 1089.

The deadline for all is 31st July.

#### **Countryside Productivity Scheme**

The RDPE Countryside Productivity Scheme provides funding for projects in England which improve productivity in the farming and forestry sectors and help create jobs and growth in the rural economy. It is administered by the Rural Payments Agency. Under the RDPE Countryside Productivity Scheme, there are grants for:

- Improving forestry productivity (application deadline 3<sup>rd</sup> April 2018)
- Water resource management and reservoirs (application deadline 29<sup>th</sup> June 2018)
- Adding value to Agri-food products (application deadline 29<sup>th</sup> June 2018)
   Grants to fund projects that improve the processing of primary agricultural products (i.e. Annex I products), benefiting the Agri-food supply chain which will in turn improve farm productivity.
- Improving Farm Productivity (application deadline 3<sup>rd</sup> December 2018)

  Grants to fund projects that improve farm productivity through the use of robotic equipment and systems to aid crop and livestock production; increasing the use of renewable energy produced on farm; the use of LED wavelength controlled lighting to aid crop production; more efficient use of livestock slurries and manures, and digestate.

The grants are funded by the European Agricultural Fund for Rural Development (EAFRD).

#### The Prince's Countryside Fund

The Herefordshire Federation of Young Farmers' Clubs (HFYFC) working in partnership with Herefordshire Rural Hub have secured funding to provide support for training in a rurally based career to the end of December 2019. The funding is easy to access. All you need to do is select which course you would like to go on and complete the application form. If your application is approved you will be able to reclaim 70% of your training and test costs, up to a maximum of £250. Applicants must be a current member of HFYFC or a past HFYFC member (up to 40 yrs old).

The fund will support training that will; *improve your employability, increase or improve your skill set, improve your safety or allow you to undertake extra responsibility in your current job.*

# The Jack Hughes Fund - administered by Herefordshire Community Foundation

The Jack Hughes Fund will fund up to a maximum of 70% pf the cost of training or costs up to a maximum of £150. Funding will be limited to one family member/employee per annum

The 2017 programme will be available for farmers <u>aged</u> <u>over 40</u> and will specifically provide funds to support those who require:

- retraining or upskilling as they are leaving the industry
- training to support a new farm diversification enterprise
- training or business support for succession planning

#### Funding will also be available for the following courses:

- Safe use of pesticides PA1, PA2, PA6
- Rodent control on farms
- Emergency first aid
- Food safety (Basic Food Hygiene)
- Chainsaw Maintenance & Cross Cutting (CS30)

The funding is easy to access, but please note that the project will not support training retrospectively and places will be limited. Applicants need to be resident in Herefordshire.

#### What will the LEADER Programme do?

The main objective is to create jobs and economic growth by supporting rural businesses.

The programme themes are:

- Support for micro and small enterprises, including farm diversification
- Support for rural tourism
- Support for increasing farm productivity
- Support for increasing forestry provision
- Provision of rural services
- Support for cultural and heritage activities

Project applications will be eligible from:

- Micro businesses (0-9 employees) and small businesses (10-49 employees)
- Qualifying micro and small farming and forestry businesses
- Social enterprises
- Voluntary organisations
- Community groups
- Parish councils based in rural Herefordshire

#### How will I know if our project is eligible?

LEADER funding contributes to around 40% of total project costs. Cash match funding will be needed for around 60% of each project. This is a predominantly capital grant programme. Training, skills and running costs are not eligible for funding. Business addresses must be registered in the Herefordshire LEADER area.

#### What outputs could my project achieve?

An output is a measurable assessment of performance and success.

The main outputs for the program are: a) Jobs created & b) Businesses or holdings benefitting

**How much can we apply for?** Projects may be eligible for a grant of £2,500 up to a maximum of normally £35,000 to fund specific activities. Higher grants may be awarded to projects demonstrating exceptional output levels.

ATV Thefts – For those who have had Quad bikes stolen, you will know the costs and frustration involved. Many are simply rolled onto a trailer and away, or driven off. So based on my experiences here are some suggestions. There are numerous tracking devices, wheel locks, Quad Vices etc...on the market but before you spend a penny, try my top five tips to make it more difficult to simply roll it away

- 1. Store it out of sight
- 2. Take the key out of it

- 3. Chain it to the floor/post or other immovable object
- 4. Lock the door to the secure storage unit it's now in!
- 5. Take a fuse out/disconnect fuel pump/disconnect starter
