Derogations for Cutting hedges in August

BPS claimants who wish to sow Oilseed Rape and/or Temporary Grassland in August, and who need to be able to cut hedges in those fields before 1st September, must apply for a derogation in order to avoid breaching cross compliance requirement GAEC 7a Boundaries.

Applications must be made on paper or by email to the RPA. They have set a 15 working day response target, and you must have received your written confirmation before the work can commence. So please apply early!

The correspondence to the RPA should be clearly marked '**Cross compliance derogation**', and should contain the following information:

Claimant name and address / SBI number / Field reference numbers

Confirmation that you wish to sow oilseed rape and/or temporary grassland on these parcels in August

If you wish to cut both sides of a hedge, you will need to list both the relevant field numbers and be sowing oilseed rape and/or temporary grassland in both fields.

All paper derogation requests need to go to: **Rural Payments Agency, PO Box 352, Worksop, S80 9FG.**

The letter must be clearly marked 'Cross Compliance derogation'.

Email requests must be sent to: ruralpayments@defra.gsi.gov.uk and marked 'Cross Compliance derogation'

Ensure emails are only sent from email addresses which are registered with RPA on rural payments online and the person sending the email is registered to the business and has permission to act for the business.

Important Changes to Red Tractor Beef and Lamb Standards

As of 1st June 2018, you will be assessed against new Red Tractor Beef and Lamb standards, relating to antibiotic use on farm. These amendments reflect the industry's commitment to being responsible users of antibiotics. In brief, members will be required to work with their vet to review health and performance data. The review must be written down, and there is a template for the vet to fill in – <https://assurance.redtractor.org.uk/contentfiles/Farmers-6897.pdf>

This review includes looking at medicine records and prescription data that outlines total antibiotic use, to make recommendations as to where farms can use antibiotics as responsibly as possible.

Other changes include the use of Highest Priority Critically Important Antibiotics and recommendations for disease prevention strategies.

Nuffield Farming Scholarships 2018

Farming is about to face the biggest change for generations. Do you want to be at the front end of those changes?

Since the 1947 Agricultural Act there have been many changes in the way UK farming has had to adapt and over that period several hundred Nuffield Farming Scholars, including over twenty from Herefordshire, have scoured the world for ideas, opportunities and innovations which have helped UK farmers to become more proficient.

A Nuffield scholarship is an 'international passport' for global travel which opens doors not usually open and scholars become members of a vast international net-work. No formal post school educational qualifications are required by applicants.

With the imminent changes to the support mechanisms post Brexit, the new era will entail new thinking to counter the loss of CAP support. It will require new approaches related to productivity, volatility, profitability and sustainability, coupled to the envisaged swing towards a more environmentally oriented support system.

When Lord Nuffield established the Nuffield Farming Scholarships in the immediate post war period of food shortages, he did so to enable farmers and others involved in the food chain to seek out ideas world-wide which would help farmers increase food production.

Post Brexit the industry will need a new approach to be able to react in a positive way to new scenarios including how to face volatility and how to react to support systems based on environmental payments.

So history will be repeating itself and there will be a need once again to scour the world for new approaches, innovations and new market opportunities.

Are you going to be one of those people between 25 and 45 years old, who would like to go out into the world to gather information and ideas? If so apply for a Nuffield Farming Scholarship. Applications must be in by late July.

Grants to fund projects that improve farm productivity through the use of robotic equipment and systems to aid crop and livestock production; increasing the use of renewable energy produced on farm; the use of LED wavelength controlled lighting to aid crop production; more efficient use of livestock slurries and manures, and digestate.

The Prince's Countryside Fund

The Herefordshire Federation of Young Farmers' Clubs (HFYFC) working in partnership with Herefordshire Rural Hub have secured funding to provide support for training in a **rurally based career** to the end of December 2019. The funding is easy to access. All you need to do is select which course you would like to go on and complete the application form. If your application is approved you will be able to reclaim **70%** of your training and test costs, up to a maximum of **£250**. **Applicants must be a current member of HFYFC or a past HFYFC member (up to 40 yrs old).**

The fund will support training that will; **improve your employability, increase or improve your skill set, improve your safety or allow you to undertake extra responsibility in your current job.**

The appraisal panel meets on the first Monday of the month. **Please ensure that you submit your application in good time before your course is due to take place, as training cannot be funded retrospectively.**

The Jack Hughes Fund - administered by Herefordshire Community Foundation

The Jack Hughes Fund will fund up to a maximum of 70% of the cost of training or costs up to a maximum of £150.

Advice on cyberbullying and online harassment

Cyberbullying and online harassment can be extremely distressing. In certain cases it can be classed as a criminal offence but there is lots of help available to support you.

Tips to stay safe online

- **Think before you post** - when posting or commenting on the internet, consider what you say and what effect it may have. Never post comments that are abusive or may cause distress to others.
- **Keep personal information personal** - avoiding saying anything or publishing pictures that might later cause you or someone else embarrassment. Be aware of what friends post about you, or how they reply to your posts, particularly about your personal details and activities.
- **Make the most of privacy settings** - keep your profiles closed, allowing access only to your chosen friends and family.
- **Report cyberbullying to internet service providers** - lots of content on social media that is offensive or upsetting is not necessarily a criminal offence. However, cyberbullying often violates the terms and conditions established by social media sites and internet service providers. Report cyberbullying to the social media site so they can take action against users abusing the terms of service.

- If you believe that you are the victim of an offence, always keep a record of the content by taking a screenshot, for example.
- If you are worried that your child or a loved one might be the victim of cyberbullying there are some signs to look out for including: Low self-esteem, Withdrawal from family and spending a lot of time alone, Reluctance to let parents or other family members anywhere near their mobiles or laptops etc and finding excuses to stay away from school or work.

What can the police do?

If we consider a message or post to be potentially criminal, we will take appropriate action. This could involve arresting the person responsible or interviewing them under caution. Cases involving sustained abuse or where someones life is threatened will be treated very seriously.
