### Making Tax Digital for VAT

If you run a VAT-registered business with a taxable turnover above the VAT registration threshold (currently £85,000) you will be required to keep digital VAT business records and send returns using Making Tax Digital (MTD) compatible software for VAT periods starting on or after 1<sup>st</sup> April 2019.

Businesses with a taxable turnover below the VAT threshold can also sign up for MTD for VAT voluntarily. This also applies to other VAT entities, such as charities, government bodies and limited companies.

HMRC is working with more than 150 software suppliers who have said they will provide software for Making Tax Digital for VAT in time for April 2019.

If your taxable turnover is above the VAT registration threshold you must follow the rules set out in VAT Notice 700/22 (below) by 1st April 2019.

## Update from the Wye & Usk Foundation

### Pesticide Project:

We are still out and about visiting fields identified by Severn Trent as high risk for metaldehyde use and providing advice on pesticide handling and disposal. If you would like help to improve your pesticide handling area please get in contact.

### New Natural Flood Management Project:

Funded by the Environment Agency & Herefordshire Council we will be providing advice and support to farms in target catchments that could help to reduce flooding of properties downstream. This could involve addressing compaction issues in your soil, using cover crops to protect bare ground, holding back water in streams, tree planting – all sorts of options. We will be working in the following streams over the coming months: Cheaton, Ridgemore, Bodenham, Pentaloe, Red, Twyford, Tedstone, Dulas and Yazor. ## The Prince's Countryside Fund

The Herefordshire Federation of Young Farmers' Clubs (HFYFC) working in partnership with Herefordshire Rural Hub have secured funding to provide support for training in a **rurally based career** to the end of December 2019. The funding is easy to access. All you need to do is select which course you would like to go on and complete the application form. If your application is approved you will be able to reclaim **70%** of your training and test costs, up to a maximum of **£250**. **Applicants must be a current member of HFYFC or a past HFYFC member (up to 40 yrs old).**

The fund will support training that will; **improve your employability, increase or improve your skill set, improve your safety or allow you to undertake extra responsibility in your current job.**

Some examples of training that has been funded so far:-

**B+E Trailer, Chainsaw Certification, Pesticide Applications, Shearing, Artificial Insemination, Tractor Driving, Forklift Truck Driving**

You could even apply for funding towards a **Rodent Control** course

Whatever training you are applying for, **please ensure that you submit your application in good time before your course is due to take place, as training cannot be funded retrospectively.**

Please note, the appraisal panel meets on the first Monday of the month.

## The Jack Hughes Fund - administered by Herefordshire Community Foundation

The Jack Hughes Fund will fund up to a maximum of 70% of the cost of training or costs up to a maximum of £150. Funding will be limited to one family member/employee per annum

The programme will be available for farmers **aged over 40** and will specifically provide funds to support those who require:

- retraining or upskilling as they are leaving the industry
- training to support a new farm diversification enterprise
- training or business support for succession planning

Funding will also be available for the following courses:

- Safe use of pesticides – PA1, PA2, PA6
- Rodent control on farms
- Emergency first aid
- Food safety (Basic Food Hygiene)
- Chainsaw Maintenance & Cross Cutting (CS30)

The funding is easy to access, but please note that the project will not support training retrospectively & places will be limited.

Grants to fund projects that improve farm productivity through the use of robotic equipment and systems to aid crop and livestock production; increasing the use of renewable energy produced on farm; the use of LED wavelength controlled lighting to aid crop production; more efficient use of livestock slurries and manures, and digestate.

## Stop That Thief !

### Burglary of sheds and outbuilding is still one of the main concerns amongst the rural community.

Burglary of sheds and outbuildings is still one of the main concerns amongst the rural community. Although the number of incidents remain low, it is still a major worry by people living in remote locations. Our Priority is to keep you and your property safe from harm and theft, we are therefore providing advice on how the community can help themselves from becoming victims of crime.

West Mercia Police have a scheme called "Stop That Thief" aimed at helping businesses and farms from becoming victims of crime. This can add another layer of security to your home, farm or other business where vulnerabilities are identified during a site specific assessment. These start with a visit from your local Officer or the Rural Business Crime Officer and if appropriate a referral to a Stop That Thief! specialist who will carry out a technical survey, to look at ways to help protect your property. This will be fully discussed with you to make sure it fulfils your requirements. Any security measures required are installed by a trained technician, on a try before you buy basis. This compliments the advice provided during a visit by your local officer on crime reduction measures including security marking and property listing. All visits and advice are offered free and without obligation. Costs for the fitting of any equipment, if agreed, will be made clear during the specialist survey.
